- I for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, hereby release and hold harmless the Student Driver listed above and their guardians and parents with respect to any and all injury, disability, death, or loss or damage to person or property incident to my child's riding with the Student Driver listed above to and from field trips, whether arising from the negligence of the releasees or otherwise, to the fullest extent permitted by law.
- I for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next

of kin, hereby release and hold harmless Mounds Park Academy, its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, and sponsors with respect to any and all injury, disability, death, or loss or damage to person or property incident to my child's driving, or riding with the Student Driver listed above, to and from field trips whether arising from the negligence of the releasees or otherwise, to the fullest extent permitted by law.
